New Delhi: Innovation has been recognized as an engine of socio-economic growth and wellbeing worldwide. Apart from playing an important role in the priority areas such as Robotics, Energy & Power, Manufacturing, IT and Telecom etc., innovation also addresses critical needs in the social sector.

CII launched Industrial Innovation Awards in the year 2014. The purpose of this Award was to encourage industry to adopt a structured Innovation Framework in their operations and measure their performance periodically on the way to moving up the Innovation Value Chain. The Framework has been widely appreciated by the industry and the number of applications for this coveted award has been increasing year by year.

In a glittering awards ceremony hosted by Confederation of Indian Industry, the apex industry body, recognized top 25 companies across large, medium and small segments to be the most innovative for the year 2018.

While presenting the awards Dr. Mitra said that "Spearheading the whole culture of innovation and entrepreneurship is a National Mission which can be achieved through seamless collaboration between government, industry and R&D. He further mentioned that for India to become the S&T prowess and knowledge economy in the 21st century, there is a need to integrate three triads i.e. knowledge generation- research, knowledge dissemination- education, and knowledge application- innovation in a seamless manner. Over the past few years, Government of India has taken several initiatives like STI policy of 2013, Technology Development Board, BIRAC, GITA, NIDHI (National Initiative for Development and Harnessing Innovations), IMPRINT, Uchhatar Avishkar Yojana and PM fellowship. He also mentioned other government initiatives like AGNIi; Knowledge clusters and; I-STEM, enable seamless virtual connect between institutions for effective networking. Going forward, favourable policies and program paradigms would encourage private sector investment in R&D. Government is pushing direct funding of industry led R&D projects with 50:50 model, promoting close collaboration of industry with academia and national labs for knowledge and infrastructure sharing, mandating a minimum percentage of industrial revenue in R&D investment sectorally, encouraging investment of a by other non-scientific ministries and states in R&D, so that there is a paradigm change in the landscape of innovation culture in our country.



As part of Industries push to promote industrial innovation, Mr Rajan Navani, Chairman, CII Council on Future Business mentioned that today companies are in a process of continuous innovation with new products, new services, new markets and new business models. He further mentioned that "without the box thinking" is gaining momentum and creating a culture of continuous innovation and revolutionizing industry for future growth.
